ePrescribe and COVID-19

In order to minimize COVID-19 exposure and promote safe prescribing, please utilize electronic prescribing (eRx) as much as possible.

The benefits of ePrescribing include:

- Reducing contact points for virus transmission
- Decreasing medication errors due to illegible handwriting or pharmacy transcription problems
- Improving pharmacy efficiency during a time that poses staffing challenges
- Ensuring the prescription is ready for patients when they arrive at the pharmacy; patients spend less time at the pharmacy

The **patient's preferred pharmacy** is essential to the eRx process. Please ensure that this information is completed or updated prior to sending the prescription electronically.

COVID-19 PowerPlan Update

COVID-19 PowerPlans (PPs) are available in both iConnect and iExtend.

- The Multi-State Division and West Florida Division order set is called “COVID-19 Core Content” (iConnect).
- There are two Central Florida Division order sets: “COVID-19 Inpatient Medications Non-ICU” and “Admission COVID-19 ICU” (iExtend).
