Home Monitoring Program

The Home Monitoring Program is an evidence-based model that delivers hospital-level care in a patient's home. Our goal at AdventHealth is to implement a limited COVID-19-specific program that will enable us to safely care for a significant number of patients in their homes to prevent health care facilities from being overwhelmed and limit exposure to health care providers. The program's aim is to manage a portion of the COVID-19 patients who could be monitored at home with enhanced monitoring and who do not reach full-blown respiratory failure and do not require ICU-level care.

This is objectively achieved with these critical steps:

- 1) Remote patient monitoring (RPM) through Vivify software: telemonitoring, pulse oximeter and thermometer
- 2) Clinical telehealth through home health RN and regional provider support
- Home oxygen supply to patients enlisted as persons under investigation (PUIs) or COVID-19-positive, if clinically indicated

These documents cover inclusion and exclusion criteria, workflow, technology and the equipment needed to enroll patients who are PUIs or COVID-19 positive. It is ultimately up to the bedside clinician to determine who would be a good candidate.

The corporate Supply Chain has ordered thermometers and pulse oximeters for all regions. We anticipate these supplies will be delivered to each region by early next week.

We would like to point out some specific and quick work each region will need to do before implementing this program:

- 1. Each facility needs to designate a person in the Emergency Department (ED) and another designated team member during off hours who would enroll the patient in this program and provide equipment as ordered by the clinician. We recommend Care Management whenever possible
- 2. Physician(s) backing up the home health RNs monitoring the patients enrolled in this program will need to be established and communicated to home health (HH). The facility will need to designate an on-call provider (physician/nurse practitioner) for patients who don't have a primary care physician
