Universal Masking

Due to atypical and/or asymptomatic presentations of COVID-19, **all team members and medical staff entering a patient care facility will wear a mask** per personal protective equipment (PPE) policy. For team members in non-patient care areas, the decision to wear a mask will be made at a facility or divisional level.

Flolan Alternative Guidance: Tyvaso

Due to the short supply of flolan, **tyvaso (treprostinil)** was added in iExtend as an alternative medication and will be available in iConnect as soon as possible.
