Safely Reopening Post-COVID-19

This document outlines the criteria for safely reopening facilities. The goal of this checklist is to mitigate the risk of resurgence and protect patients and staff and can be implemented on a regional or divisional basis.

HCQ FDA Warning

On April 24, the FDA cautioned against the use of HCQ/CQ for COVID-19 outside of the hospital setting or a clinical trial, due to the risk of heart rhythm problems. The AdventHealth Treatment Algorithm for COVID-19 in Adult Patients, updated April 20, is provided here.

Medical Executive Committee Resolution on Provider and Patient COVID-19 Testing
