Appointment Cancellation Policy

Cancellations

Patients cancelling two or more consecutive appointments or cancelling an appointment without a 24-hour advance notice may be removed from the schedule for future appointments and assessed a \$50 "Cancellation" charge.

No Show

Patients who do not keep their scheduled appointment and fail to call our office at least 24 hours prior to their scheduled appointment, may be assessed a \$50 "No-Show" charge.
